Letter From the President

Holiday time is approaching. The newest 'holiday' (just passed) seems to be Halloween! Now we look forward to Thanksgiving and then Christmas. A significant commonality of each of those events is that a good deal of money is spent. We now decorate - sometimes elaborately - for Halloween. We spend freely for Thanksgiving, and if we are lucky, are able to spend time with family. We also spend *very* freely for Christmas - decorations, gifts, travel, etc. And - this is fine! If we can afford this, it is an exciting and happy time of the year.

But, there are others. While we happily make plans for the holidays, others struggle simply to buy food and pay utility bills. Accompanying that struggle come stresses that can make one dread the upcoming holidays – and coupled with uncertainty, negatively affect family life.

Helping Hands Ministry receives over 1,000 requests for help each month. But requests for help greatly exceed available funds. Each month we usually help about 65 households with financial aid, another 65 with transportation aid, and refer hundreds to other agencies for various types of assistance.

Another set of needs is characterized by those who have mental or physical limitations. In a world of computers and communications, not having knowledge and skill in this area is limiting in its own right. For those more severely limited, operating a computer and learning through well-designed exercises changes lives.

CompuPlace is expanding the computer hardware and software available to individuals with disabilities. The CompuPlace program provides computer services that are unique in Iowa. But once again, demand for the services is exceeding the resources to fund them.

In addition, the Ecumenical Center provides space for the meals programs of Green Square Meals and the Witwer Senior Center. Several non-profit agencies such as the Foman Infant Unit, Narcotics Anonymous and Cedar Rapids Aquatics receive reduced cost office space. As a result of the reduced cost space each of these programs is able to spend more of its funds on direct service.

Thank you for all you have done in the past, but the need continues and grows! The Ecumenical Center staff and board ask for your continuing generous support - please make a donation to the Center now, in anticipation of the holidays. Don Leonhart - President

Helping Hands Ministry = providing assistance & support to persons in Linn County through collaboration with the faith community and local agencies.

During the first 10 months of 2013, Helping Hands Ministry has provided:

Rent to <u>175</u> households (\$20,526.50) Electric to <u>108</u> households (\$12,092.10) Gas to <u>15</u> households (\$1,693.74) Water to <u>17</u> households (\$1,693.74) Shelter Rent to <u>58</u> households (\$1,352) Mortgage Interest to <u>1</u> household (\$150) Rent deposit to <u>32</u> households (\$3,156) Electric deposit to <u>5</u> household (\$645) Identification/Birth Cert for <u>20</u> HH (\$215.75) Water deposit to <u>2</u> household (\$257.10) 4,300* Local Bus Tickets for <u>662</u> persons (\$1,950) Auto Gas to <u>45</u> households (\$900)

*Note: 400 bus tickets were donated to Helping Hands Ministry

For a total of **\$44,762.08 to 643 households** (36 households received both service and bus tickets) A total of 626 households received local bus tickets only.

Other activities have included:

Cedar Rapids Downtown Farmer's Markets were attended July 6, August 3, September 21 by HHM staff and HHM Steering Committee members. The HHM lip balms were distributed and merchandise was sold.

Administration of the First Lutheran Church Shepherd's Fund was transferred to HHM in August to provide auto gas vouchers to needy households. HHM had been doing part of the screening and then sending clients to First Lutheran. This transfer of \$300 for auto gas, \$100 for bus tickets and \$175 for shelter rent (\$575/month) will provide services to more households above and beyond the monthly budget for HHM.

Jessica & Sarah represented the ECC and HHM at the Mission of Hope's Hopefest held August 10th. Over 600 cookies were distributed and many questions answered. They also were representatives at the Veterans Stand Down on September 6.

The HHM Steering Committee has reviewed the draft of the HHM five year long range strategic plan and will submit it to the December ECC Board for approval and implementation January 1, 2014.

<u>COMPUPLACE</u>: A Specialized Computer Learning Lab for People with Intellectual Disabilities and / or Needs for Assistive Technology

Between January 1 and September 30 2013, 118 individuals received over 1374 hours of CompuPlace services.

Still, there are others who we did not reach. According to the most recent American Community Survey data for Iowa and Linn County, over 23,000 of us who live in Linn County have disabilities. Most CompuPlace clients have a cognitive disability. In Linn County, 9000 of us have a cognitive disability.

CompuPlace also serves people with a variety of other disabilities when they need specialized instruction and / or Assistive Technology like touch screens, switches and trackballs, speech, or magnification.

Help us to reach more learners! Volunteer your time teaching or preparing educational games and activities. Take photos and short videos for us. Record some sounds for celebration of correct choices in our games. Help us gather and format information for Trivia games. Your monetary gifts help support our program and sponsor more learners. WINDOWS 7 HAS IMPROVED ACCESSIBILITY FEATURES!

CompuPlace will soon be installing Windows 7 and 8, and also Microsoft Office, on several computers in our lab. Updates will allow us to teach many new, exciting and useful office-related skills to our clients!

To turn on the Ease of Access Center in Windows 7 – Win + U :

Press and hold down the Windows key, the one with the Window on it in the lower row of your keyboard, near the spacebar. While you're holding down the Windows key, tap the letter U key. From this Ease of Access Center, you can — ALT + N or ALT + G:

- Turn on the Windows Narrator: hold down the ALT key and tap the letter N key.
- Turn on the Windows Magnifier: hold down the ALT key and tap the letter G key. Other features may be useful for you or for someone you know. Create a restore point before you make changes so that you can easily return the settings to the way they were.

IRA GIFT TRANSFERS:

GOOD NEWS! There is still time to make Tax-Free Gifts from IRA accounts. The American Taxpayer Act of 2012 which extends the law that allows donors to make charitable gifts from their IRA accounts during tax years 2012 and 2013 without incurring income tax on the withdrawal is scheduled to expire December 31, 2013. So if you are age 70-1/2 or older, are required to take minimum withdrawals, and you do not need them for personal use, this may be a great way to make a gift to qualified charities for tax year 2013. While you cannot claim a charitable deduction for IRA gifts, you will not pay income tax on the amount.

Margaret Bock Housing (MBH) continues to have a variety of activities in its everyday management of the building and tenants. For an example of on-going responsibilities, see the second paragraph below. At this time, MBH is also planning a gradual internal facelift that will include new beds, mattress and box spring covers, paint, carpet in the hallways, plus a new washing machine. These upgrades are needed as a result of many years of use by tenants. We want the ECC community to have the opportunity to be a part of these improvements. Consequently we are asking for donations of time and material or money so that we can keep moving ahead. Grants for this type of upgrade are difficult to find, so kindly consider an investment in housing for low income individuals who strive to achieve stability in their lives.

One might ask, what variety of on-going work occurs at MBH. On a frequent basis, property manager Mike, cleaning lady Marie, board volunteers, plus a few tenants handle a variety of tasks. Some of these, in NO order of priority or frequency, are:

- 1. Interview candidates for tenant occupancy.
- 2. Collect rent and pay operating costs.
- 3. Cleaning and painting and maintenance
- 4. Deal with a variety of tenant issues.
- 5. Coordinate with Orkin for pest treatments and inspections.
- 6. Provide monthly income and balance sheet financials.
- 7. Monthly board and tenant policy council meetings.
- 8. Coordinate information with the ECC BOARD.

If activities such as these are or could be of interest to you, read on. If providing housing to prevent homelessness is an interest of yours, any financial help from you is much appreciated.
